Further, banks should scan all existing accounts to ensure that no account is held by or linked to any of the entities or individuals included in the list.
- Banks are advised to strictly follow the procedure laid down in the UAPA 4. Order dated August 27, 2009 enclosed to our circular **DBOD.AML.BC. No.** 44/14.01.001/2009-10 dated September 17, 2009 and ensure meticulous compliance to the Order issued by the Government.
